IMPACT Project: new initiative



Targeted trainees

Law Enforcement Officials, such as:

- Intellectual Property Offices dealing with enforcement
- Customs Authorities
- Public Prosecutors
- Police



Type of the training

Online / In-person



Duration

1 - 2 years



Requirements

- Trainees must be associated with enforcement related organizations
- Trainees should work for two years within the relevant organizations after finishing the training program.

I Training



➤ Online Training

Online training consists of courses conducted over the internet, covering various topics including the fundamentals of intellectual property, investigation of intellectual property crimes, cross-border infringement of goods, and more

➤ In person training

Training program to be held in the host country with the presence of expert trainers in IP enforcement



I Evaluation

- Evaluating knowledge and satisfaction after each session, with follow-ups for skill integration
