## **GUEST SPEAKER PROFILES**

**Ms. CAI Ye,** Partner, Wanhuida Intellectual Property, Beijing, China

CAI Ye is a Partner based in the Beijing office of Wanhuida Intellectual Property. She started her intellectual property practice, with a focus on trademark, since 2008.

Her expertise encompasses trademark prosecution including registration, opposition, review, cancellation action and administrative litigation arising from trademark prosecution. She also has a broad experience in copyright registration, Customs recordal of IPRs, and domain name disputes. Ye graduated from Beijing Foreign Studies University where she obtained LLB and BA. Before joining the firm in 2016, Ye practiced at the Beijing office of Marks & Clerk and before that a leading PRC law firm.

**Mr. R. A. TIWARI,** Advocate and Of Counsel, M/s ALG India Law Offices LLP [Former Deputy Registrar of Trademarks and GI, under the office of the Controller General of Patents, Designs and Trademarks (CGPDTM), Government of India]

Mr. R. A. Tiwari is former Deputy Registrar of Trademark & Geographical Indications having more than 29 years of service in the office of the Controller General of Patents, Designs and Trademarks (CGPDTM), Government of India, which administers the Intellectual Property (IP) laws in India.

Before joining the government office, he had a bachelor's degree in science (B. Sc.), and bachelor's degree in law (LL. B) from Banaras Hindu University, Varanasi, India; and thereafter he had practiced law as an advocate before a District Court in India for more than 5 years.





After retirement from the Government service in the year 2020, he has again started practicing law [in particular, the law relating to trademarks] as an Advocate and IP Attorney. Presently staying at Mumbai, he is also working as Of Counsel of a Delhi based law firm M/s ALG India Law Offices LLP. During his government service he assisted the then CGPDTM by supervising all the functions relating to trademarks in his office. He was an officer instrumental in implementation of the Madrid System concerning international registration of marks, in India. After India's accession to the Madrid Protocol, he had supervised all the functions of the office as an 'Office of Origin' and as an 'Office of the Designated Contracting Party' under the Madrid Protocol. As an Of Counsel of the ALG India Law Offices, he mostly helps the firm in representing the registrants of the international registrations before the Indian IP office regarding the provisional refusals and defending the protection of their marks in India. Ms. Attiva MALIK, Senior Attorney-Advisor, Office of Policy and International Affairs (OPIA), United States Patent and Trademark Office (USPTO) Ms. Malik started her career at the USPTO as a trademark examining attorney. She then joined the USPTO Trademark Policy Office as an attorney-advisor workina on United States national trademark examination and registration policies and procedures. She was charged with creating and updating policy guidance for, and providing training to, USPTO staff and external users on various trademark examination and registration topics. Thereafter, Ms. Malik moved to the USPTO Office of Policy and International Affairs. She focuses on international and national trademark law and practice, and participates in bilateral and multilateral discussions and developments relating to South Asia and Southeast Asia. She also provides information and training on USPTO trademark policy and practice to foreign audiences and is the primary point of contact for the Madrid Protocol and non-traditional marks.

**Mr. Allan ROGERS**, Examination Technical Lead, Secure Trade Marks & Designs (Secure TMD), The Intellectual Property Office of the United Kingdom (UKIPO)

Mr. Rogers joined the UKIPO as a trade mark examiner before progressing to work as a senior trade mark examine. He now works as an examination technical lead advising UK trade mark examiners on procedures, practice, and decisions. Mr. Rogers is part of the Madrid System teams within the UKIPO in its role as both an Office of Origin and a Designated Contracting Party. This involves liaising with WIPO to assist in resolving issues, as well as advising examiners on processing of international applications and examination of international registrations. In his current role, he also updates policy documentation, revises internal processes, and delivers training to UK trade mark examiners with a particular focus on comparison of marks and examination of marks containing geographical indications. Mr. Rogers also trains new trade mark examiners, delivers internal informational sessions, and delivers training courses on trade marks to external stakeholders through the UKIPO's IP Masterclass program.
