




E-SERVICES IN ALBANIAN PUBLIC ADMINISTRATION

- A total of 255 public institutions are currently connected through GOVnet.
- There are 473 official websites in use by Albanian public institutions.
- The number of online services offered by Albanian public institutions has reached 1,245, facilitated by E-Albania.
- There are 63 systems integrated into a unified gateway to facilitate interoperability.

E-Albania

The "e-Albania" government platform is the government interaction platform for the provision of electronic services that is administered and developed by **the National Agency for the Information Society** and serves as a gateway through which any interested person can receive, via the Internet, electronic services provided by public institutions in Albania.






IP data exchange with WIPO


GDIP has developed an advanced digital system for IP protection that aligns with European and international standards.

• Madrid e-Filing: Albanian businesses can file international trademark applications online through WIPO's Madrid System, allowing global protection with a single application.

• Real-Time Trademark Data Sharing: GDIP shares trademark data with WIPO Global Brands, ensuring Albanian trademarks are visible worldwide.

• WIPO IP Portal Access: Track trademark status, renew registrations, and manage IP rights digitally.

European Patent Validation: **Albania is a validation state** for European patents, and applicants can request validation online through GDIP's system.


Espacenet Access: GDIP facilitates access to EPO's global patent database, helping Albanian innovators check existing patents.
