Access to IP information is crucial for:

- i. Ensuring quality examinations in IP Offices
- ii. Promoting further innovation and the creation of IP
- iii. Helping businesses avoid infringing on the IP rights of others


The current IP systems follow the principle of territoriality, but ...

Technology and designs know no borders

Business is becoming increasingly globalized

**Global IP information provision is necessary** 

So, HOW?



It seems easy, but in reality, there are many problems and difficulties


- Burden of multiple bilateral negotiations with other IP Offices
- Differences in data ownership and commercialization policies (redistribution, third party use, free of charge, for a fee, etc.)
- Technical issues (data quality and consistency, differences in data format, non-machine-readable data, etc.)
- Lack of a common data exchange platform

# **IP5 Information Dissemination Policy 2011**

Common policy among IP5 Offices to support a barrier-free flow of IP information for the mutual benefit of the offices and the public

- Data shall be provided free of charge or at marginal cost
- Any data exchanged shall be shared with the other IP5 Offices
- Exchanged data can be provided to third parties (except for third-party IP Offices) for external and commercial use
- Data provision to third-party IP Offices is allowed under the reciprocity principle



Dec. 2023

Japan and Saudi Arabia made separate proposals both relating to IP data exchange

#### Japan

Setting new WIPO Standard on IP data exchange policies, including a common understanding of IP Offices' responsibilities, third-party use authorization, data quality, data structure, etc.

### Saudi Arabia

Creation of a global data exchange platform, under the supervision of WIPO, aimed at standardizing the IP data provided by disparate sources

## Approval of New Task on IP Data Exchange at CWS/12

Sep. 2024

- The results of the IP data exchange survey conducted by WIPO IB after CWS/11 were presented
- A consolidated project brief was submitted by Japan and Saudi Arabia

Co-leaders: WIPO, Saudi Arabia, Japan


A new CWS Task (Task No. 67) and a corresponding Task Force (IP Data Exchange Task Force) were approved

Proposed description for Task No. 67:

*"Analyze existing practices and challenges experienced by IP offices with a view to explore solutions to improve global IP data exchange"*

#### IPDETF/2025/1 (February. 13, 2025)

- Survey results on current practices and challenges in IP data exchange have been shared
- Initial discussions were held on common issues related to IP data exchange and the IP data exchange platform

#### IPDETF/2025/2 (April 24, 2025, Scheduled)

#### IPDETF/2025/3 (June 12, 2025, Scheduled)

- The importance of global IP data exchange and sharing is growing
- It is beneficial not only to larger Offices but also to smaller Offices and users worldwide
- The JPO is committed to making the new CWS task a leading example of global collaboration among IP Offices by sharing our long-standing collaborative experiences in data exchange
