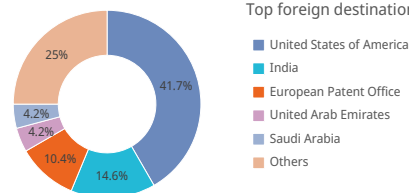

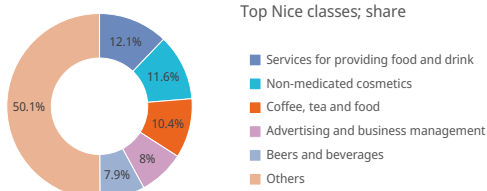

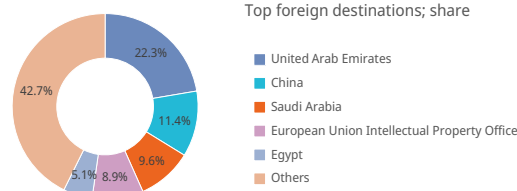
Trademark class count in applications \*







**Note**

(1) For trademarks, filings refer to the number of classes specified in applications.

(2) For industrial designs, filings refer to number of designs contained in applications.

(3) Statistics are produced regardless of whether the home office of the applicants supplied statistics or not. An asterisk symbol indicates that the home IP office did not supply statistics.

(4) Statistics relating to "technical fields" are extracted from the Patstat database and are based on the publication date.

(5) The indicator "resident applications per million population" is available for countries with a polulation greater than one million. The "indicator per GDP" is available for countries whose total GDP exceeds 10 billion US Dollar.

(6) Percentage with a plus or minus symbol indicates the percentage change from the previous year.

(7) Both national and regional data are used to establish the list of countries relating to non-resident filings.
