Dear Mr. Lindqvist,

Please accept my warm congratulations on your appointment as the President and Chief Executive Officer of the Internet Corporation for Assigned Names and Numbers (ICANN).

As a veteran of the Internet, your appointment coincides with important moments for the Domain Name System (DNS): ICANN's planned introduction of further new generic Top Level Domains (gTLDs); discussions around both Internet governance generally and concerning the future of registration data specifically, including its importance for Intellectual Property owners; and, ICANN's decision to initiate a policy review of the Uniform Domain Name Dispute Resolution Policy (UDRP).

Comprised of 193 Member States, the World Intellectual Property Organization (WIPO) leads the development of a balanced and effective global intellectual property ecosystem to promote innovation and creativity for a better and more sustainable future.

Having managed nearly 75,000 cases since its inception, WIPO is the globally-recognized leader in the provision of not-for-profit domain name dispute resolution services under the UDRP which was adopted by ICANN as its first Consensus Policy in 1999 on the basis of a Report produced by WIPO and which since then has been regarded as an international policy success for ICANN. Unique among UDRP case administration providers, WIPO's Arbitration and Mediation Center (AMC) continues to invest in the UDRP and in the spirit of section 13.1 of ICANN's Bylaws, has commenced a review of the UDRP to inform ICANN's policy process which we trust will prove useful

I am pleased to also note that WIPO has responded positively to ICANN's call for Request for Information (RFI) both for Legal Rights Objections – which it successfully managed in the last new gTLD round, and also for String Confusion Objections in the context of ICANN's new gTLD Program.


