Travel and Other Arrangements for the

Patent Cooperation Treaty (PCT) Working Group

Eighteenth Session February 18 to 20, 2025

WIPO will provide the designated person with an air ticket in economy class from the location of his/her Office to Geneva and return. On receipt of the completed participation form, the designated person will be informed personally of the procedures to be followed in this connection. WIPO will not reimburse the cost of any ticket bought by the designated person without prior authorization from WIPO.

WIPO will also provide the designated person with a daily subsistence allowance ("DSA" for hotel accommodation, meals and miscellaneous expenses) for the period of the meeting in Geneva at the applicable United Nations rate. The rate for Geneva is currently 381 Swiss francs per night (subject to change). In addition, a lump sum of 224 Swiss francs in respect of terminal expenses (for taxis, porters and other incidental expenses) on departure and arrival will be provided.

A medical insurance, covering accident and urgent medical care following an illness, provided by WIPO, will cover the period away from home on mission.
